

- **In case of weather conditions that do not comply with the FAI regulations, wind > 8 m/s, rain or the like. the competition is suspended until adequate weather conditions are met for the continuation of the competition.**

**Competition Jury:** 3 people will be chosen from among the contestants before the start of the competition.

**Competition director:** Stevan Janović

**Delegate of the competition:** Đeorgievski Lazo

**Complaints:** Competitors have the right to file complaints against referee decisions. They are submitted in writing to the jury, which will be chosen from the contestants present (composed of three members chosen before the competition), and upon completion of the last flight in a certain class with a deposit of RSD 3,000, which will be returned to the competitor in case of a positive outcome. The decisions of the Competition Jury are final.

**Responsibility for participation in the competition:** Participation in the competition is voluntary and the organizer of the competition ie. the immediate organizer bears no responsibility in case of injury or material damage caused by or to third parties.

**Other:** During the competition, the use of aircraft other than competition models is not allowed, and in particular, the use of drones for entertainment, filming without appropriate written approvals and permits from the organizers and competent authorities of the Republic of Serbia is strictly prohibited.
